

Recruitment Notice of Talents for Law School of Nanchang University (2026)

I. Basic Eligibility Criteria

1. Applicants shall hold a postgraduate degree and a doctoral degree, or possess the title of Professor, with graduate education from high-level universities, research institutes, or renowned overseas universities. They shall have an outstanding educational background in all academic stages, and their major shall be close to or related to the requirements of the recruited position.
2. The age of applicants shall generally not exceed 32 years old. For those with particularly excellent qualifications, the age limit may be relaxed to under 40 years old.

II. Position Requirements for Talent Introduction (2026)

Meet the basic eligibility criteria for talent introduction, and possess profound academic attainments in legal science, Discipline Inspection and Supervision Studies and other related professional fields.2. Have strong team organization capabilities, have achieved important representative achievements in the disciplinary (professional) field, and demonstrate excellent academic competitiveness and great development potential.3. Possess the ability to formulate development plans for the disciplinary field, put forward innovative ideas for discipline construction and academic research, and be able to lead the corresponding disciplinary field to achieve breakthrough development and enhance the discipline's reputation and competitiveness at home and abroad.4. Preference will be given to candidates with the title of Professor or equivalent academic qualifications, as well as rich experience in discipline development and team management.

The candidate's academic major shall cover majors related to the discipline of law (including intellectual property law) and majors such as Discipline Inspection and Supervision Studies (0308).

Have achieved outstanding academic results in relevant research fields, possess the ability to preside over scientific research projects at or above the provincial and ministerial level, and be able to provide strong support for discipline development and talent cultivation. 3. For candidates with the title of Associate Professor or above and a doctoral degree, the age limit may be appropriately relaxed.

Meet the basic eligibility criteria for talent introduction. The candidate's major shall be limited to Discipline Inspection and Supervision Studies (0308), Law (0301), Political Science (0302) and other majors related to Discipline Inspection and Supervision Studies. 2. Possess solid professional basic knowledge and good teaching capabilities, and be able to undertake the teaching tasks of core courses for the major of Discipline Inspection and Supervision Studies. 3. Have certain scientific research potential, be willing to participate in the scientific research projects and discipline development work of the Discipline Inspection and Supervision Studies, and contribute to the characteristic development of the discipline.
<p><i>Faculty Postdoctoral Fellow</i></p>	<ol style="list-style-type: none"> 1. Meet the basic eligibility criteria for talent introduction, and the candidate's major shall meet the development needs of the discipline of law (including intellectual property law) or Discipline Inspection and Supervision Studies. 2. The age shall generally not exceed 30 years old. Candidates shall have excellent character and academic performance, have obtained a doctoral degree for no more than 3 years, have no other personnel and labor relations after entering the station, transfer their personal files to the university, and work full-time at the university. 3. Meet the admission requirements of the university's postdoctoral research station. 4. The candidate's academic achievements shall meet one of the following requirements: publishing 1 paper in a top journal or at an important academic conference of the discipline; or publishing at least 2 papers in CSSCI source

General Postdoctoral Fellow	<p>1. Meet the basic eligibility criteria for talent introduction, and the candidate's academic major shall be related to the discipline of law (including intellectual property law) or the disciplinary field of Discipline Inspection and Supervision Studies.</p> <p>2. Possess good scientific research literacy and research capabilities, and be able to assist the supervisor in conducting research on scientific research projects of the corresponding discipline.</p> <p>3. Strictly abide by the relevant regulations on postdoctoral training and complete the research tasks on schedule.</p>
